In consideration of the above, I, for myself, my child, my family, spouse, heirs, representatives and assigns, as applicable, hereby accept all responsibility and liability for the above named student during such transportation and until the student arrives from the athletic trip, planned activity, or practice destination(s). I further agree to waive liability, release and forever discharge, and indemnify the individual providing transportation, Christ Church Episcopal School, its trustees, employees and agents for any liability arising from all demands, rights, and causes of action of whatever kind or nature, arising out of all known and unknown, foreseen and unforeseen bodily and personal injuries, damage to property, and the consequences thereof, including death, resulting from such independent transportation. This release is without reservation of any kind except only for such acts or omissions on the part of the individual providing transportation, Christ Church Episcopal School, its trustees, employees and agents that arise out of grossly negligent, intentional, willful, or wanton wrongdoing and without fault of any kind on the part of my child.
